REGULATION REGARDING EARLY VOTING FOR LANDSKAP ELECTIONS

-UNOFFICIAL TRANSLATION-

REGULATIONS ABOUT EARLY VOTING FOR LANDSKAP ELECTIONS

- The members of the Nation shall as far as possible be given opportunity to participate in the decisions regarding the Nation. The purpose of this regulation is to give the members of the Nation the opportunity to vote in advance for certain positions.
- These regulations are applicable for the election of First curator, Second curator, Third curator, Kitchen master, Pub master, members of the board, members of the property board as well as the activity auditor.

TIME FOR EARLY VOTING

3 § Early voting can be done during the normal office hours, starting when the summons to the Landskap has been sent up until the day for the Landskap itself.

VOTING PROCEDURE

- 4 § The First curator, or a person appointed by the First curator, shall receive votes from the members of the Nation that fills the criteria in the Nation's bylaws 2:4 and in accordance with § 3 in this regulation.
 - 5 \int The early voting is made in person or by postal vote. All elections are made through secret ballots.
- 6 § The electoral roll and given votes shall be stored securely during the election period. The received ballots shall never be left without supervision.

HOW TO VOTE

- 7 § The Nation member gives one ballot per election that the member wants to participate in.
- 8 \(\) To prepare the vote, the member shall
 - 1. Write the name of the candidate that the member wants to elect,
 - 2. Put the ballot in an envelope,
 - 3. Mark the envelope with which election it is for, and
 - 4. Seal the envelope.
 - 9 § The vote is prepared in seclusion and is there after handed to the ballot receiver.

HOW THE RECEIVING OF BALLOTS IS CONDUCTED

- The Nation member shall have access to empty ballots to be used for the election, an election screen, pens, names and presentations of the candidates, the by-laws of the Nation, regulations, and post descriptions as well as this regulation.
- 11 § The Nation member shall show ID as well as fulfill the stipulated demands in the Nation's by-laws 2:5 to be able to participate. Ombud shall show ID for themselves as well as the person the ombud is voting for. A member who has not yet paid for the membership shall be able to do so in connection with the voting procedure.
- 12 § The election officer shall
 - 1. Mark in the election roll which members that fulfill the regulations in § 11,
 - 2. Mark for which elections the member has participated, and
 - 3. Make a note of the election roll number on all the envelopes, and
 - 4. Put the respective envelopes in for that specific election designated folders.

CHANGING OF VOTE

13 § The Nation member can change the vote. The changed vote can be put after the member have gotten the previous made vote back from the election officer.

In connection with the returning of the vote, the previous name is removed from the electoral roll.

LANDSKAP

- Participation at Landskap is possible through video link. Members of the Nation that participates through link has the right to speak and make suggestion but not to vote.
- 15 § The Chairperson of the Landskap is responsible for making sure that the Landskap is conducted in accordance with the recommendations given by Folkhälsomyndigheten.

The number of members participating at the Nation can be limited by the Chairperson of the Landskap. If a member is denied access, the member shall be instructed on how to participate through link.

The right to participate cannot be limited for the Chairperson of the Landskap, the First curator, the minutes keeper, as well as two appointed adjustors of the protocol and two appointed vote counters.

HOW THE COUNTING OF THE VOTES IS CONDUCTED

- 16 \(\) At election, all election ballots as well as the election roll shall be given to the vote counters.
- 17 § The elections are counted separately. The counting shall for each election be conducted accordingly:
 - 1. The number of envelopes and the number of members that have participated according to the election roll shall be counted.
 - 2. The envelopes for members that have voted more than once shall not be approved and be put to the side.
 - 3. The election ballots shall one by one be removed from the approved envelopes and be placed in the urn. If an envelope contains more than one vote, these votes shall not be approved and be put back in the envelope.

Unofficial translation.

- 4. The voting ballots that has been placed in the urn shall be sorted in groups to the candidates. The number of ballots shall be counted.
- 5. The result shall be noted in a specific voting protocol.
- 18 § Further regulations regarding the counting of the votes are available in § 13 in the Reglemente för Landskap.

RESULT

- 19 § Immediately after the vote counting has been finished, the vote counters shall hand the voting protocol to the Chairperson of the Landskap who then announces the result.
- 20 § Regulations regarding the validity of the decisions of the Landskap as well as the right for a member of the Nation to make a note of their opinion in a certain matter, are available in the Nation's by-laws, 2:10-11.
